Domestic Bourse Index Gains 0.36% amid Sustained Bargain Hunting Activity; NIBOR Falls for all Tenor Buckets amid Renewed Liquidity Ease...

The local equities market advanced by 0.36% to 40,295.95 points amid sustained bullish activity even as the Exchange recorded 27 gainers as against 20 losers at the close of trading session. Hence, the year-to-date loss of the NSE ASI turned positive at 0.06%. Specifically, we saw buying interest in Insurance stocks such as AIICO, LASACO and MANSARD as their share prices rose by 2.68%, 8.33% and 9.57% respectively; hence, the NSE Insurance index gained 3.61%. Similarly, share price of DANGCEM advanced by 2.22%. The NSE Consumer Goods and NSE Industrial indices rose by 0.99% and 0.36% respectively. However, the NSE Banking and NSE Oil/Gas indices fell by 0.62% and 0.05% respectively. Meanwhile, activity in the market was upbeat as total deals, volume and value of stocks traded increased by 4.74%, 247.46% and 220.11% to 5,591 deals, 1.16 billion units and N7.6 billion respectively. Elsewhere, NIBOR moderated for most tenor bucket amid renewed liquidity ease; also, NITTY fell for most maturities tracked. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; also, the value of FGN Eurobond fell for all maturities tracked.
