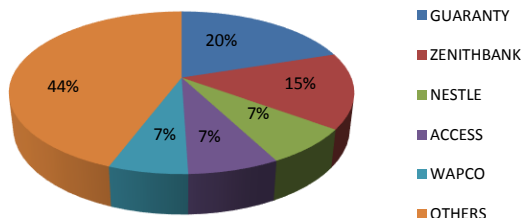
Local Equities Market Advances by 0.52% amid Sustained Bullish Activity; NIBOR Closes Flat for most Tenor Buckets...

The domestic market closed the week positive as its ASI increased by 0.52% to 41,176.14 points even as the Exchange recorded 42 gainers as against 12 losers. Consequently, the year-to-date gain of the NSE ASI climbed to 2.2%. Notably, buy pressure on Tickers such as FLOURMILL, MTNN, WAPCO and ACCESS lifted their respective share prices by 9.33%, 1.19%, 1.28% and 2.11% respectively. Of the five indices tracked, four closed in green except for the NSE Oil/Gas index which moderated by 0.54%. The NSE Banking, NSE Insurance, NSE Consumer Goods and NSE Industrial indices gained 0.54%, 4.14%, 1.41% and 0.08% respectively. Meanwhile, activity in the market was mixed as total volume and value of stocks traded fell by 17.64% and 28.18% to 0.66 billion units and N6.3 billion respectively. Elsewhere, NIBOR closed flat for most tenor bucket; however, NITTY moderated for most maturities tracked amid demand pressure. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; also, the value of FGN Eurobond fell for all maturities tracked amid demand pressure given the sustained increase in oil prices.
