

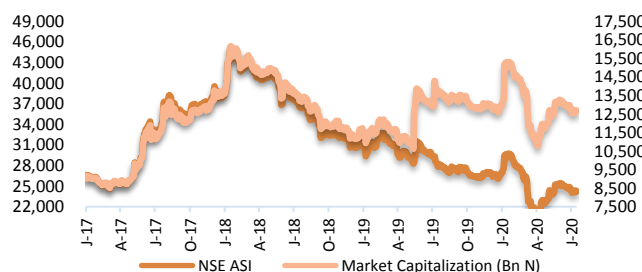

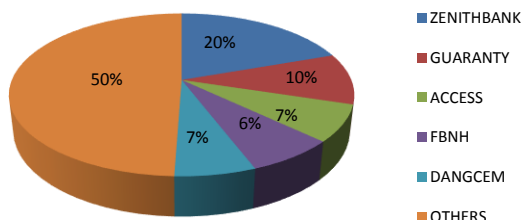

Local Equities Market Falls by 0.23% amid Renewed Bearish Activity; NIBOR Rises for most Tenor Buckets amid Renewed Liquidity Strain...

The domestic market began the week in negative territory as its ASI moderated by 0.23% to 41,082.38 points; albeit the Exchange printed more gainers (36) than losers (22). Hence, the year-to-date gain of the NSE ASI lowered to 2.0%. Notably, we saw investors sold part of their holdings in large cap stocks such as DANGCEM, FLOURMILL, UBA and ZENITHBANK to book profit amid their recent price increase. Hence, their respective share prices fell to 1.01%, 5.49%, 1.62% and 0.57% respectively. Performance across sub-sector was bullish as three out of the five indices tracked closed in green; the NSE Banking, NSE Insurance and NSE Oil/Gas indices rose by 0.01%, 5.98%, 0.02% respectively. On the flip side, the NSE Consumer Goods and NSE oil/Gas indices declined by 0.62% and 0.43% respectively. Meanwhile, activity in the market was mixed as total deals and volume of stocks traded rose by 5.94% and 10.79% to 7,396 deals and 0.73 billion units; however, the value of stocks fell by 34.76% to N4.1 billion respectively. Elsewhere, NIBOR and NITTY rose for most tenor bucket amid renewed liquidity strain. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, the value of FGN Eurobond fell for all maturities tracked.
