
Local Equities Market Dips Further by 0.07% amid Sustained Profit Taking Activity; NIBOR Falls for most Tenor Buckets amid Renewed Liquidity Ease...

The domestic market sustained yesterday's southward movement as its ASI contracted by 0.07% to 41,051.63 points following profit taking on mid and large cap stocks. We saw share prices of UACN, ARDOVA, BUACEMENT and ACCESS declined by 5.39%, 8.63%, 1.13% and 3.65% respectively. Consequently, the year-to-date gain of the NSE ASI fell to 1.9% despite the Exchange printing more gainers (42) than losers (22). Sectorial performance was also bearish as three out of the five indices tracked closed in red zone; the NSE Banking, NSE Oil/Gas and NSE Industrial moderated by 0.73%, 0.46% and 0.36% respectively. On the positive side, the NSE Insurance and NSE Consumer Goods indices rose by 6.29% and 0.56% respectively. Meanwhile, activity in the market was mixed as total deals and volume of stocks traded fell by 19.34% and 28.91% to 5,965 deals and 0.52 billion units; however, the value of stocks rose by 27.90% to N5.3 billion respectively. Elsewhere, NIBOR fell for most tenor bucket amid renewed liquidity ease; also, NITTY moderated for most maturities amid demand pressure. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; however, the value of FGN Eurobond rose for all maturities tracked.
