## Cowry Daily Market Insight 21 January 2021

Local Equities Market Index Moderates by 0.12% amid Sell-offs on Insurance Stocks; NIBOR Fell for most Tenor Buckets amid Renewed Liquidity Ease... At the close of Thursday's trading session, the domestic bourse index fell by 0.12% to close at 41,099.15 points amid renewed profit taking activity, especially on large cap stocks. Hence, the year-to-date gain of the NSE ASI moderated to 2.05% even as the number of losers (50) outweighed that of the gainers (14). For the sub-indices, the NSE Insurance index fell by 6.70% amid renewed bearish sentiment on insurance stocks - we saw share prices of MANSARD, AIICO and CHIPLC closed lower. Also, share prices of MTNN and UBA closed southward. The NSE Banking and the NSE Consumer Goods index declined by 0.23% and 0.30% respectively. On the positive side, the NSE oil/Gas and NSE Industrial index rose (despite the decline in share price of DANGCEM) by 0.15% and 0.27% respectively. Meanwhile, activity in the market was positive as total deals, volume and value of stocks traded increased by 17.60%, 72.61% and 38.72% to 7,404 deals, 1.12 billion units and N6.3 billion respectively. Elsewhere, NIBOR fell for most tenor bucket amid renewed liquidity ease; albeit, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; however, the value of FGN Eurobond rose for maturities tracked.
