



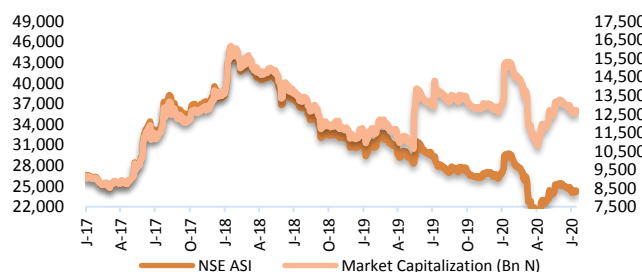

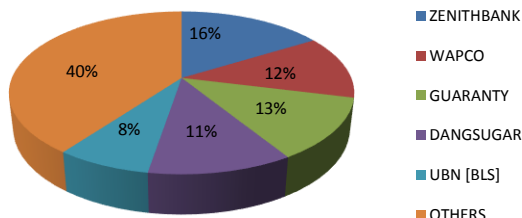
Local Equities Market Index Advances by 0.57% amid Sustained Bullish Activity; NIBOR Rises for most Tenor Buckets amid Renewed Liquidity Strain...

The domestic bourse All Share Index (ASI) rose by 0.57% to close at 41,169.41 points amid sustained bargain hunting activities even as the Exchange printed 28 gainers as against 21 losers at the close of trading session. Hence, the year-to-date gain of the NSE ASI rose to 4.71%. Specifically, Tickers such as STANBIC, JBERGER, NB, WAPCO and ZENITHBANK were the toast of investors today as their respective share prices climbed by 5.91%, 9.95%, 3.28%, 2.71% and 3.03%. Sectorial performance was bullish as three out of the five indices tracked closed in green; the NSE Banking, NSE Consumer Goods and NSE Industrial indices rose by 2.11%, 0.94% and 0.21%. On the flip side, the NSE Insurance and NSE Oil/Gas indices fell by 0.56% and 1.75%. Meanwhile, activity in the market was mixed as total deals and value of stocks traded fell by 5.67% and 21.28% to 6,386 deals and N5.76 billion respectively; however, the volume of stocks traded rose by 2.16% to 0.55 billion units. Elsewhere, NIBOR rose for most tenor bucket amid renewed liquidity strain; also, NITTY rose for all maturities tracked amid higher yields as yields at the primary market continue to rise. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, the value of FGN Eurobond moderated for maturities tracked.
