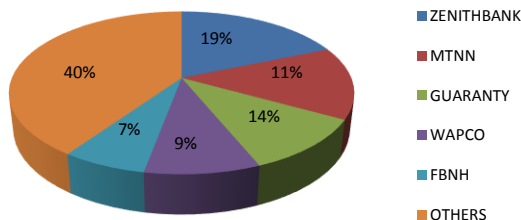
Local Equities Market Index Climbs by 0.58% amid Sustained Bullish Activity; NIBOR Rises for most Tenor Buckets amid Sustained Liquidity Strain...

The domestic bourse closed the week northwards as All Share Index (ASI) inched higher by 0.58% to close at 42,412.66 points amid sustained positive investors sentiment. Hence, the year-to-date gain of the NSE ASI rose to 5.31%. Also, the Exchange printed 29 gainers as against 25 losers as we saw mixed reactions to Unaudited Q4 2020 earnings releases. Notably, buy interest on counters such as MTNN, GUARANTY and UACN lifted their respective share prices higher by 3.31%, 1.45% and 2.40%. Of the five indices tracked, four closed in green save the NSE Industrial index which fell by 0.08%. The NSE Banking, NSE Insurance, NSE Consumer Goods and the NSE Oil/Gas indices advanced by 0.52%, 0.91%, 0.32% and 0.63% respectively. Meanwhile, activity in the market was upbeat as total deals, volume and value of stocks traded rose by 4.34%, 20.63% and 14.36% to 6,663 deals, 0.66 billion units and N6.59 billion respectively. Elsewhere, NIBOR rose for most tenor bucket amid sustained liquidity strain; also, NITTY rose for most maturities tracked amid sell pressure. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; however, the value of FGN Eurobond advanced for all maturities tracked amid demand pressure.
