



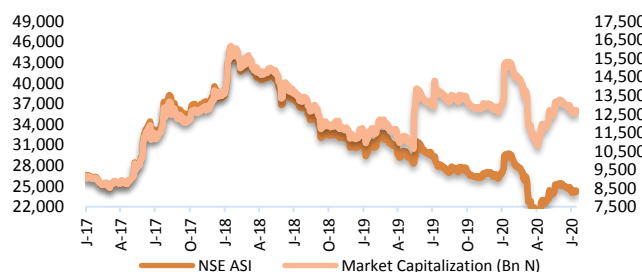

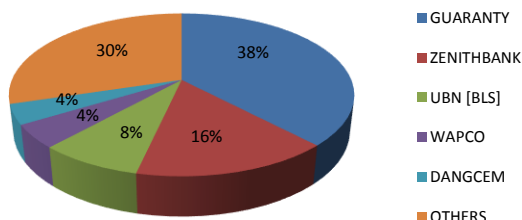
Local Equities Market Index Moderates by 0.10% amid Sustained Bearish Activity; NIBOR Closes Flat for most Tenor Buckets...

At the end of Wednesday's trade, the domestic bourse All Share Index (ASI) fell by 0.10% to close at 42,000.01 points amid sustained profit taking activity. Hence, the year-to-date gain of the NSE ASI declined to 4.2% even as the number of losers (27) outweighed that of the gainers (19). Specifically, investors continue to book profit on bellwethers such as WAPCO, GUARANTY and FLOURMILL; hence their respective share prices lowered by 1.61%, 2.07% and 3.03%. Similarly, performance across sub-sector gauges tracked was bearish as all the sub-indices tracked closed southwards; the NSE Banking, the NSE Insurance, NSE Consumer Goods, NSE Oil/Gas and NSE Industrial indices contracted by 0.14%, 2.09%, 0.22%, 0.05% and 0.12% respectively. Meanwhile, activity in the market was mixed as total deals and volume of stocks traded moderated by 17.20% and 9.21% to 5,887 deals and 0.50 billion units respectively; however, the value of stocks traded rose to N5.3 billion. Elsewhere, NIBOR closed flat for most tenor bucket; albeit, NITTY moderated for most maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, the value of FGN Eurobond rose for all maturities tracked amid demand pressure.
