Local Equities Shed 1.96% amid Sustained Bearish Activity; NIBOR Rises for most Tenor Buckets amid Renewed Liquidity Strain...

Bearish sentiments persisted in the equities market, resulting in across-the-board price declines amid relatively attractive yields in the fixed income space. Hence, the All-Share Index (ASI) moderated by 1.96% to close at 40,696.01 points even as the number of losers (37) outweighed that of the gainers (13). Also, the year-to-date gain of the NSE ASI plunged to 1.05%. Specifically, large cap stocks such as ZENITHBANK, DANGCEM, WAPCO and UBA suffered major setbacks as their respective share prices fell by 3.10%, 7.39%, 2.62% and 6.90%. Of the five indices tracked, four closed in red except for the NSE oil/Gas index which closed flat. The NSE Banking, the NSE Insurance, NSE Consumer Goods and NSE Industrial indices declined by 3.36%, 1.15%, 0.38% and 3.70% respectively. Meanwhile, trading activity was upbeat as total deals, volume and value of stocks traded increased by 15.07%, 19.92% and 38.74% to 5,718 deals, 0.36 billion units and N5.4 respectively. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; also, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds fell for most maturities tracked; however, the value of FGN Eurobond rose for all maturities
