



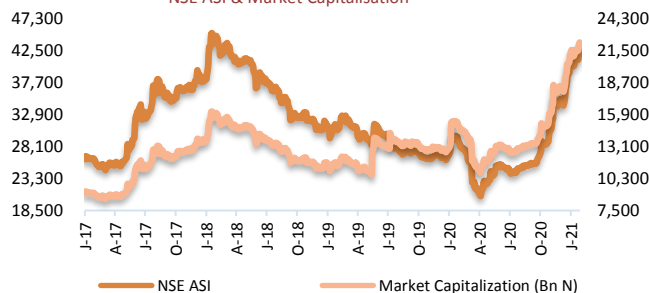

Local Equities Market Index Falls by 1.40% amid Renewed Bearish Activity; NIBOR Rises for most Tenor Buckets amid Renewed Liquidity Strain...

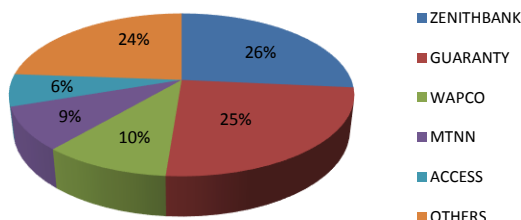
The equities market closed the week southwards as its All-Share Index (ASI) moderated by 1.40% to 40,439.85 points amid profit taking on Industrial stocks. Hence, the year-to-date gain of the NSE ASI fell to 0.42%. The Exchange printed more gainers (36) than losers (7) as investors hunted for bargains given the lower re-entry prices for most stocks. However, profit taking on heavy weight stock such as MTNN, DANGCEM and BUACEMENT muted the bullish activity in the market. We saw their respective share prices contract by 0.49%, 3.51% and 7.22%. Of the five indices tracked, four closed in green zone; the NSE Banking, the NSE Insurance, NSE Consumer Goods and NSE Oil/Gas indices increased by 0.52%, 0.04%, 0.28% and 0.14% respectively. However, the NSE Industrial index plunged by 4.55%. Meanwhile, trading activity was weak as total deals, volume and value of stocks traded fell by 19.05%, 68.96% and 18.86% to 5,321 deals, 3.95 billion units and N5.1 respectively. Elsewhere, NIBOR rose for all tenor buckets amid renewed liquidity strain; also, NITTY rose for most maturities tracked amid sustained sell-offs. In the OTC bonds market, the values of plain vanilla FGN bonds moved in mixed directions across maturities tracked; however, the value of FGN Eurobond rose for all maturities tracked.
