

Domestic Equities Market Index Rises by 0.63% amid Renewed Bullish Activity; NIBOR Falls for all Tenor Buckets amid Renewed Liquidity Ease...

The local bourse index rose by 0.63% to 38,931.25 points amid renewed bargain hunting activity; albeit, the Exchange printed equal number (23 apiece) of gainers and losers at the close of trading session. Consequently, the year-to-date loss of the NSE ASI shrank to -3.32%. Specifically, blue-chip stocks were the toast of investors today as share prices of NESTLE, DANGCEM and SEPLAT advanced by 1.85%, 3.64% and 0.02% respectively. Sectorial performance was positive as three out of the five indices tracked closed in green territory; the NSE Insurance, NSE Consumer Goods and the NSE Industrial indices rose by 0.18%, 0.40% and 0.74% respectively. On the flip side, the NSE Banking and the NSE Oil/Gas indices fell by 0.35% and 0.02% respectively. Meanwhile, trading activity was weak as total deals, volume and value of stocks traded fell by 3.88%, 24.85% and 26.17% to 4,437 deals, 0.36 billion units and N4.9 billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid renewed liquidity ease; however, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; also, the value of FGN Eurobond increased for most maturities tracked.
