Nigerian Equities Market Index Rises by 0.54% amid Renewed Bargain Hunting Activity; NIBOR Falls for most Tenor Buckets amid Renewed Liquidity Ease...

At the end of Thursday's trade, the local bourse index rose by 0.54% to close at 38,914.84 points as investors bought more of banking stocks given the recent decline in share prices of most tier 1 banks. This was despite the rise in the 364-day bill to 7% from 6.5% at the primary auction yesterday. Hence, the year-to-date loss of the NSE ASI moderated to -3.36% even as the bulls (22) outnumbered the bears (12). Specifically, share prices of GUARANTY, ZENITHBANK, UBA and WAPCO rose by 6.43%, 7.32%, 1.43% and 2.73% respectively; hence, lifting the NSE Banking and the NSE Industrial indices by 4.40% and 0.16% respectively. On the flip side, the NSE Insurance, NSE Consumer Goods and the NSE Oil/Gas indices moderated by 0.78%, 0.24% and 0.13% respectively to close in red. Meanwhile, trading activity was upbeat as total volume of stocks traded ballooned by 727.76% to 1.46 billion as 1billion worth of UNITYBANK exchanged hands today. Elsewhere, NIBOR fell for most tenor buckets amid renewed liquidity ease; however, NITTY moderated for most maturities tracked given the roughly flat T-bills auction by CBN; 91- day and 182-day bills were flattish at 2% and 3.5% respectively. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; albeit, the value of FGN Eurobond rose for all maturities tracked.
