

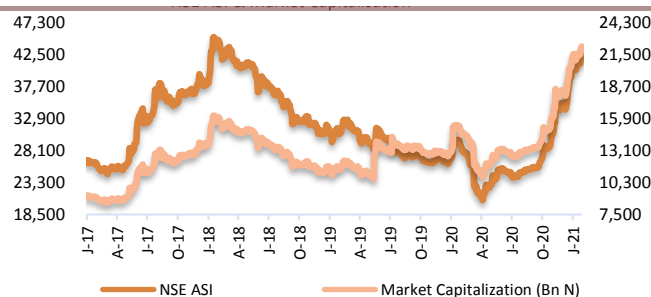

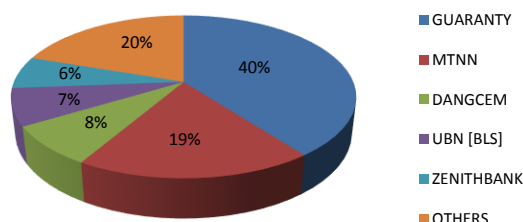
Domestic Equities Market Index Rebounds by 0.98% amid Positive Corporate Releases; NIBOR Rises for most Tenor Buckets amid renewed Liquidity Strain...

The local bourse index advanced by 0.98% to 39,085.78 points amid renewed bargain hunting activity even as the Exchange recorded higher number of gainers (20) than losers (16) at the close of trading session. Hence, the year-to-date loss of the NSE ASI lowered to -2.94%. Specifically, we saw investors react positively to the FY 2020 corporate releases and dividend declaration as tickers such as DANGCEM and STANBIC benefited from investors' patronage. Their respective share prices rose by 2.27% and 9.99%. Three out of five sectoral indices tracked closed in green zone; the NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices rose by 0.73%, 0.68% and 0.65% respectively. On the other hand, the NSE banking and the NSE Insurance indices fell by 0.21% and 0.56% respectively. Meanwhile, trading activity was positive as total deals, volume and value of stocks traded rose by 2.06%, 30.54% and 86.75% to 4,018 deals, 0.36 billion units and N5.70 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; also, NITTY rose for all maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; albeit, the value of FGN Eurobond rose for most maturities tracked.
