

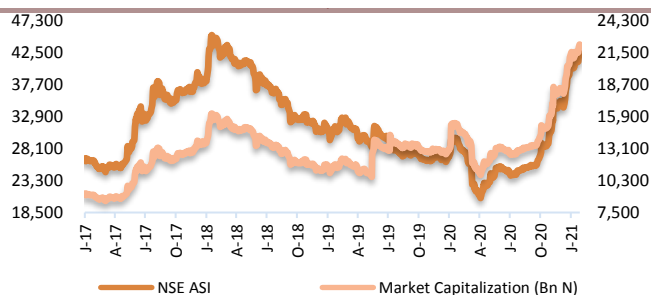

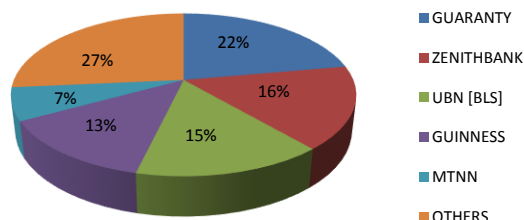

Domestic Equities Market Index Falls by 0.20% amid Renewed Bearish Activity; NIBOR Rises for most Tenor Buckets amid Renewed Liquidity Strain...

The local bourse closed the week in negative territory following sell-offs in mid and large cap stocks; hence the NSE ASI declined by 0.20% to 39,216.20 points. Consequently, the year-to-date loss of the NSE ASI rose to -2.61%; despite the bulls (20) outnumbering the bears (13). Specifically, investors sold part of their holdings in tickers such as MTNN, CAP, STANBIC and UBA as their respective share prices moderated by 1.84%, 4.55%, 1.70% and 0.73%. Sectorial performance was positive as three out of the five indices tracked closed in green zone; the NSE Banking, NSE Consumer Goods and the NSE Industrial indices rose by 0.48%, 0.51% and 0.08% respectively. On the flip side, the NSE Insurance and the NSE Oil/Gas indices moderated by 0.39% and 0.20% respectively. Meanwhile, trading activity was mixed as total deals and value of stocks traded fell by 6.72% and 26.21% to 3,746 deals and N2.79 billion respectively; however, the volume of stocks traded rose by 9.37% to 0.25 billion units. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; albeit, NITTY move in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; also, the value of FGN Eurobond fell for all maturities tracked.
