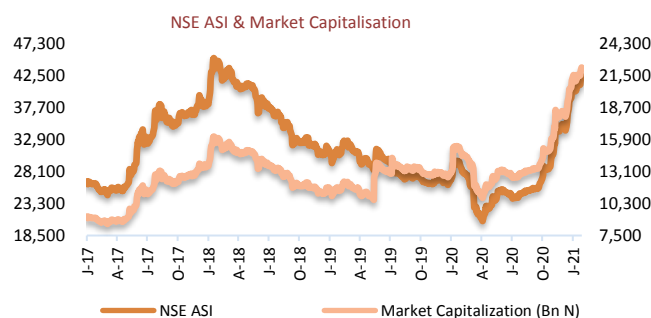




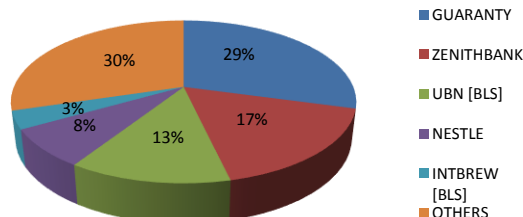
## Domestic Equities Market Index Falls by 0.57% amid Renewed Bearish Activity; NIBOR Rises for most Tenor Buckets amid Renewed Liquidity Strain...

The local bourse index moderated by 0.57% to close at 39,267.11 points amid renewed profit taking activity despite printing 22 gainers against 13 losers at the close of trading session. Hence, the year-to-date loss of the NSE ASI rose to -2.49%. Specifically, sell pressure in symbols such as DANGCEM, JBERGER, ETI and AIICO lowered their respective share prices by 4.02%, 2.68%, 4.72% and 3.97% respectively. Sectorial performance was mixed as two out of the five indices tracked closed in green while others moved in mixed directions. The NSE Banking and NSE Consumer Goods indices rose by 0.94% and 0.07% respectively while the NSE Insurance and NSE Industrial indices fell by 0.16% and 1.90% respectively. However, the NSE Oil/Gas index closed flat. Meanwhile, trading activity mellowed as total deals, volume and value of stocks traded fell by 3.77%, 35.63% and 69.31% to 4,394 deals, 0.33 billion units and N3.26 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; also, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds rose for maturities tracked; however, the value of FGN Eurobond fell for most maturities tracked.
