#### Equities Market Sustains Bearish Trend as ASI Falls by 0.57%; NIBOR Rises for all Tenor Buckets amid Sustained Liquidity Strain...



At the close of Wednesday's trading session, the local bourse index further moderated by 0.57% to close at 39,045.13 following sell-offs on bellwethers. Hence, the year-to-date loss of the NSE ASI slipped to -3.04% even as the numbers of losers (24) outnumbered the gainers (18). Given the sell pressure on blue chips such as MTNN, WAPCO, ACCESS, GUARANTY and UBA, we saw their respective share prices fall by 2.91%, 0.67%, 3.61%, 0.45% and 2.08%. Nevertheless, performance across sub-sector gauges tracked was positive as three out of the five indices tracked closed in green; the NSE Insurance, NSE Consumer Goods and the NSE Oil/Gas indices rose by 2.22%, 0.39% and 0.02% respectively. On the flip side, the NSE Banking and the NSE Industrial indices fell by 0.84% and 0.03% respectively. Meanwhile, trading activity mellowed as total deals and value of stocks traded fell by 9.19% and 14.24% to 3,990 deals and N2.8 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid sustained liquidity strain; albeit, NITTY fell for most maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, the value of FGN Eurobond fell for all maturities
