

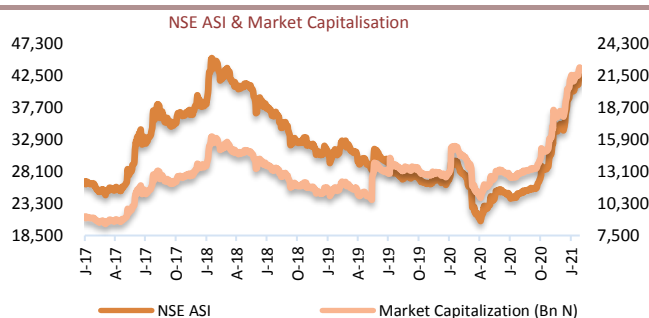


# Cowry Daily Market Insight 06 April 2021

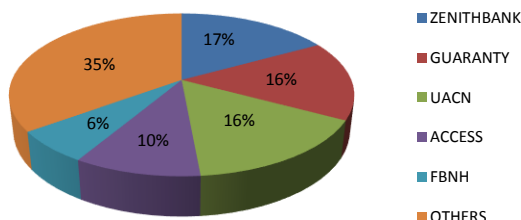
Equities Market Index Declines by 0.39% amid Sustained Bearish Activity; NIBOR Closes Flat for all Tenor Buckets...

The local bourse resumed the trading week negative as the index fell by 0.39% to close at 38,766.61 points; hence, the year-to-date loss of the NSE ASI further rose to -3.73%. Amid negative sentiment, the Exchange recorded 21 losers as against 14 gainers at the close of trading session. Notably, mid and large cap stocks suffered losses as investors sold part of their holdings in GUINNESS, OANDO, GUARANTY, ZENITHBANK and WAPCO; hence their respective share prices moderated by 8.08%, 3.13%, 3.34%, 0.90% and 0.69% respectively. Sectorial performance was weak as four out of the five indices tracked closed in red; the NSE Banking, the NSE Insurance, NSE Consumer Goods and the NSE Oil/Gas indices fell by 1.67%, 0.53%, 0.39% and 0.11% respectively. However, the NSE Industrial indices closed flat. Meanwhile, trading activity slowed as total volume and value of stocks traded fell by 6.19% and 7.43% to 0.22 billion units and N2.1 billion respectively. Elsewhere, NIBOR closed flat for all tenor buckets; albeit, NITTY moderated for all maturities tracked. In the OTC bonds market, the values of FGN bonds fell for most maturities tracked; however, the value of FGN Eurobond rose for all maturities tracked.
