


## Cowry Daily Market Insight 08 April 2021

### Local Equities Market Index Advances by 0.07%; NIBOR Falls for most Tenor Buckets amid Sustained Liquidity Ease...

The local bourse index increased by 0.07% to close at 38,799.83 points amid sustained bargain hunting activity even as the Exchange printed more gainers (13) than losers (12) at the close of trading session. Hence, the year-to-date loss of the NSE ASI fell to -3.65%. Notably, tier 1 banks were the toast of investors today as the share prices of ZENITHBANK, GUARANTY, ACCESS and UBA rose by 3.81%, 2.68%, 1.90% and 0.72% respectively. Performance was bullish across sub-sector gauges tracked as three out of the five indices tracked closed in green zone; the NSE Banking, the NSE Insurance and the NSE Oil/Gas indices rose by 2.19%, 0.60% and 0.40% respectively. However, the NSE Consumer Goods index fell by 0.20% while the NSE Industrial index closed flat. Meanwhile, trading activity mellowed as total deals, volume and value of stocks traded declined by 42.50%, 59.23% and 62.43% to 3,525 deals, 0.14 billion units and N1.5 billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid sustained liquidity ease; albeit, NITTY rose for all maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions; however, the value of FGN Eurobond rose for most maturities tracked.
