Local Equities Market Sustains Bullish Run as ASI Rises by 0.17%; NIBOR Rises for most Tenor Buckets amid Renewed Liquidity Strain...

The local bourse closed the trading week northwards as its index advanced by 0.17% to close at 38,866.39 points; albeit the Exchange printed equal number (14 apiece) of gainers and losers. Hence, the year-to-date loss of the NSE ASI lowered to -3.48%. Notably, large cap stocks such as MTNN, GUARANTY and ZENITHBANK enjoyed investors' patronage as their respective share prices pumped by 1.17%, 0.52% and 0.69%. Two out of the five sectored indices tracked closed in green; the NSE Banking and the NSE Insurance Indices increased by 0.41% and 0.15% respectively. Other sub-indices closed in mixed directions; while the NSE Consumer Goods and the NSE Oil/Gas indices fell by 0.15% and 0.33% respectively, the NSE Industrial index closed flat. Elsewhere, trading activity was mixed as total deals and value of stocks traded declined by 0.51% and 18.72% to 3,507 deals and N1.2 billion respectively. Meanwhile, NIBOR rose for most tenor buckets amid renewed liquidity strain; however, NITTY fell for all maturities tracked amid demand pressure. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; also, the value of FGN Eurobond moved in mixed directions across maturities tracked.




