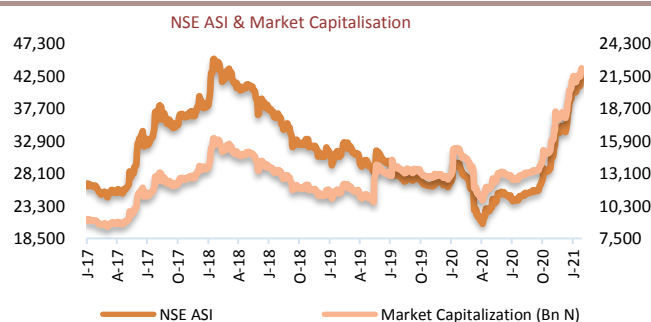


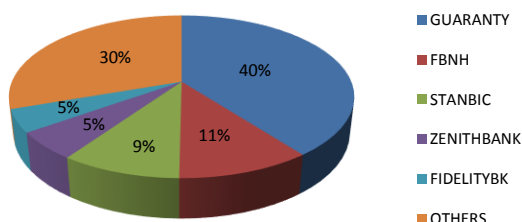
Local Equities Market Rebounds by 0.61% amid Renewed Bullish Activity; NITTY Falls for Most Maturities Tracked...

The domestic bourse closed the week positive as its index rose by 0.61% to close at 38,808.01 points; hence, the year-to-date loss of the NSE ASI lowered to -3.63%. Similarly, the bulls (23) outnumbered the bears (11) amid positive investors sentiment. Specifically, we saw bargain hunting on tickers such as DANGCEM, MTNN, GUINNESS, WAPCO and UBA, hence their respective share prices rose by 2.33%, 1.24%, 9.26%, 1.23% and 2.21%. Sectorial performance was bullish as three out of the five indices tracked closed in green; the NSE Insurance, NSE Consumer Goods and the NSE Industrial indices rose by 0.94%, 0.44% and 1.19% respectively. On the flip side, the NSE Banking index moderated by 0.52% while the NSE Oil/Gas index closed flat. Meanwhile, trading activity was mixed as total deals and volume of stocks traded fell by 15.22% and 17.82% to 3,525 deals and 0.26 billion units respectively; however, the value of goods traded rose by 37.32% to N2.4 billion. Elsewhere, NIBOR moved in mixed directions across most tenor buckets; albeit, NITTY fell for most maturities tracked. In the OTC bonds market, the values of FGN bonds fell for most maturities tracked; albeit, the value of FGN Eurobond rose for all maturities tracked.
