Local Equities Market Index Rises by 0.12% amid Sustained Bullish Activity; NIBOR Falls for all Tenor Buckets amid Renewed Liquidity Ease...

The domestic stock market resumed the week positive as its index advanced by 0.12% to close at 38,854.73 points amid sustained bargain hunting activity. Consequently, the year-to-date loss of the NSE ASI moderated to -3.51% even as the number of gainers (18) outweighed that of the losers (12). Specifically, we saw buying pressure on symbols such as UACN, MTNN, UBA, ZENITHBANK and MANSARD which lifted their respective share prices by 8.50%, 0.18%, 1.44%, 0.70% and 1.11%. Sectorial performance was positive as three out of the five indices tracked closed northwards; the NSE Banking, NSE Insurance and the NSE Consumer Goods indices rose by 0.30%, 0.40% and 0.10% respectively. On the flip side, the NSE Oil/Gas index moderated by 0.20% while the NSE Industrial index closed flat. Meanwhile, trading activity was upbeat as total value of stocks traded ballooned by 1,216.61% to N32.10 billion given the N29.67 billion worth of transactions on MTNN shares today. Hence, the deals and volume of stocks traded rose by 22.64% and 93.74% to 4,323 deals and 0.50 billion units respectively. Elsewhere, NIBOR fell for all tenor buckets amid renewed liquidity ease; albeit, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds fell for most maturities tracked. However, the value of FGN Eurobond rose for all maturities tracked.
