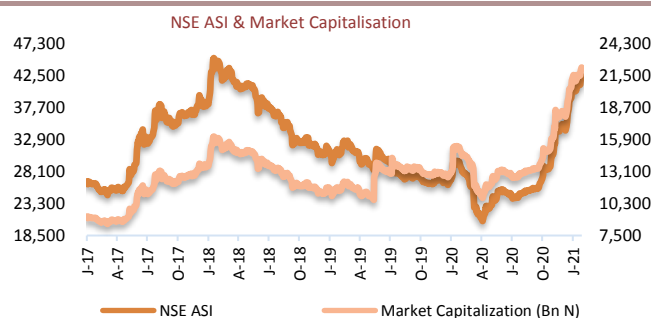


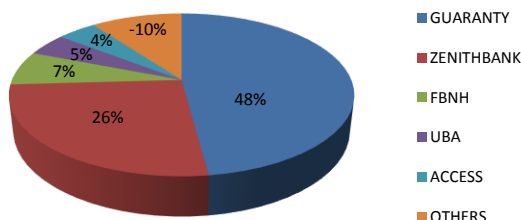
Local Equities Market Index Revs by 0.04% amid Sustained Bullish Activity; NIBOR Rises Sharply for most Tenor Buckets amid Renewed Liquidity Strain...

The domestic stock market index remained in positive territory, having gained 0.04% to close at 39,144.39 points amid sustained bargain hunting activities. Hence, the year-to-date loss of the NSE ASI lowered to -2.79%. At the close of trading session, the Exchange printed 18 gainers as against 15 losers on positive investors' sentiment. Specifically, share prices of counters such as PZ, UACN, UBA and Oando rose by 6.93%, 1.43%, 2.07% and 3.96% respectively. Nevertheless, performance across sub-sector gauges tracked was bearish as three out of the five indices tracked closed in red zone; the NSE Banking, NSE Insurance and the NSE Consumer Goods indices fell by 0.04%, 0.40% and 0.01% respectively. On the positive side, the NSE Oil/Gas index gained 0.21% while the NSE Industrial index remained flat. Meanwhile, trading activity was weak as total deals and volume of stocks traded moderated by 18.55% and 25.49% to 3,051 deals and 0.17 billion units respectively. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; also, NITTY rose for all maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions; however, the value of FGN Eurobond rose for all maturities tracked.
