Local Equities Market Closes Positive as ASI Rises by 0.43% amid Sustained Bullish Activity; NIBOR Falls for most Tenor Buckets amid Renewed Liquidity Ease...

The domestic stock market index rose by 0.43% to close at 39,301.82 points amid sustained bargain hunting activities even as the Exchange recorded 32 gainers as against 9 losers at the close of trading session. Hence, the year-to-date loss of the NSE ASI moderated to -2.40%. Specifically, sentiment was positive in the market as share prices of tickers such as STANBIC, NB, DANGSUSGAR, WAPCO and ZENITHBANK advanced by 8.70%, 2.20%, 5.29%, 1.83% and 1.36% respectively. Of the five indices tracked, four closed in positive territory except for the NSE Oil/Gas index which closed flat. The NSE Banking, NSE Insurance, NSE Consumer Goods and the NSE Industrial indices rose by 0.51%, 0.57%, 0.94% and 0.11% respectively. Meanwhile, trading activity picked up as total deals, volume and value of stocks traded rose by 14.36%, 56.36% and 51.34% to 3,489 deals, 0.17 billion units and N2.9 billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid renewed liquidity ease; also, NITTY fell for all maturities tracked. In the OTC bonds market, the values of FGN bonds closed flat for most maturities tracked; however, the value of FGN Eurobond fell for all maturities tracked.
