





Bulls Maintain Grip as NSE ASI rose by 0.05%; NITTY Rises for all Tenor Buckets amid Sell Pressure...

The domestic stock market index resumed the week positive as the All-share Index advanced by 0.05% to close at 39,319.75 points amid sustained positive investors sentiment. Hence, the year-to-date loss of the NSE ASI lowered to -2.36%. Also, the Exchange recorded more gainers (25) than losers (17) as investors patronized medium and large cap stocks. Share prices of tickers such as NB, WAPCO, GUARANTY, FIDSON and LASACO increased by 1.56%, 1.12%, 0.32%, 9.09% and 7.14% respectively. However, performance across sub-sector gauges tracked was bearish as three out of the five indices tracked closed in red zone; the NSE Banking, NSE Consumer Goods and the NSE Oil/Gas indices fell by 0.07%, 0.01% and 0.34% respectively. On the positive side, the NSE Insurance and the NSE Industrial indices rose by 2.22% and 0.07% respectively. Meanwhile, trading activity was weak as total deals, volume and value of stocks traded declined by 19.38%, 28.18% and 60.93% to 2,813 deals, 0.20 billion units and N1.1 billion respectively. Elsewhere, NIBOR moved in mixed directions across tenor buckets; however, NITTY rose for all maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions across maturities tracked; however, the value of FGN Eurobond fell for most maturities tracked.
