Domestic Equities Market Halts Uptrend as ASI Declines by 0.03%; NIBOR Rises for most Tenor Buckets amid Renewed Liquidity Strain...

The domestic stock market index moderated by 0.03% to settle at 39,305.48 points following sell-offs in banking stocks. Hence, the year-to-date loss of the NSE ASI rose to -2.39% despite the Exchange printing more gainers (23) than losers (16) at the close of trading session. Specifically, the NSE Banking subsector gauge was the lone loser as its index fell by 0.60% following sell-offs in tier 1 banking tickers. We saw share prices of GUARANTY, UBA, ACCESS, ZENITHBANK and FBNH decline by 0.48%, 1.33%, 1.32%, 0.45% and 0.67% respectively. On the positive side, the other sub-sector gauges tracked closed in green zone: the NSE Insurance, NSE Consumer Goods, NSE Oil/Gas and NSE Industrial indices increased by 0.96%, 0.03%, 0.19% and 0.01% respectively. Meanwhile, trading activity was weak as total deals and volume of stocks traded declined by 21.86% and 23.31% to 2,198 deals and 0.15 billion units respectively. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; however, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds moderated for maturities tracked; also, the value of FGN Eurobond fell for most maturities tracked.
