

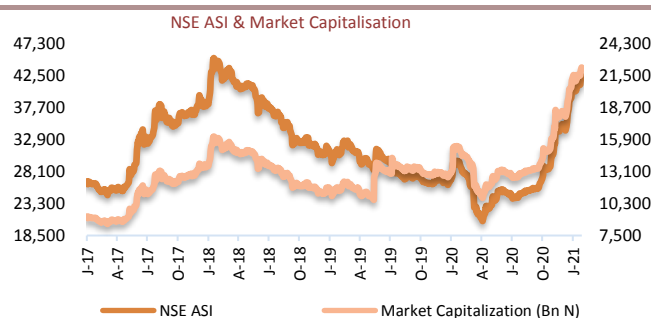

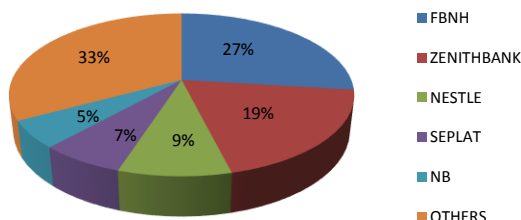
Domestic Equities Market Index Falls by 0.01% amid Sustained Bearish Trend; NIBOR Declines for most Tenor Buckets amid Renewed Liquidity Ease...

The domestic stock market index moderated marginally by 0.01% to settle at 39,303.09 points amid sustained bearish activity even as the Exchange printed 23 losers as against 19 gainers at the close of trading session. Hence, the year-to-date loss of the NSE ASI rose to -2.40%. Specifically, mid and large cap stocks such as GUINNESS, ARDOVA, PZ, GUARANTY and WAPCO moderated by 575%, 3.24%, 7.41%, 0.48% and 0.44% respectively. Sectorial performance was weak as three out of the five indices tracked closed in red zone; the NSE Banking, NSE Insurance and the NSE Consumer Goods indices dwindled by 0.20%, 1.60% and 0.10% respectively. On the positive side, the NSE Oil/Gas index rose by 2% while the NSE Industrial index closed flat. Meanwhile, trading activity picked up as total deals, volume and value of stocks traded rose by 61.37%, 69.04% and 48.53% to 3,547 deals, 0.25 billion units and N1.9 billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid renewed liquidity ease; also, NITTY fell for all maturities tracked. In the OTC bonds market, the values of FGN bonds moderated for all maturities tracked; also, the value of FGN Eurobond fell for most maturities tracked.
