

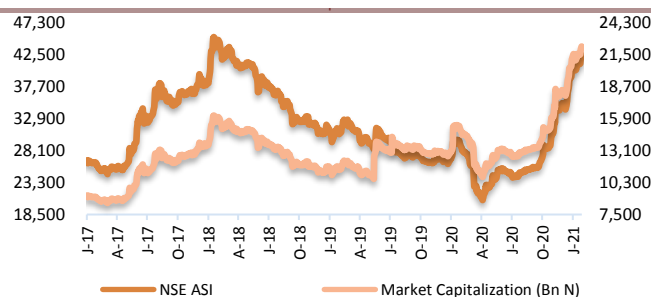

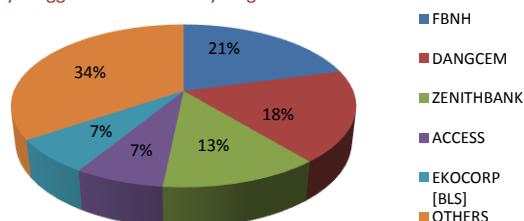

Domestic Equities Market Index Rebounds by 1.75% on Industrial Stock; NIBOR Rises for all Tenor Buckets amid Renewed Liquidity Strain...

The domestic stock market index rose by 1.75% to settle at 39,461.20 points amid renewed bargain hunting activity even as the Exchange printed 24 gainers as against 17 losers at the close of trading session. Hence, the year-to-date loss of the NSE ASI lowered to -2.01%. Sentiment was positive in the market amid release of relatively positive Q1 2021 financial results by corporates. Tickers such as DANGCEM, MTNN, OKOMUOIL and JBERCER enjoyed investors patronage as their respective share prices rose by 7.84%, 3.94%, 5.26% and 10%. Of the five indices tracked, two closed in green zone while the rest moved in mixed directions; the NSE Insurance and the NSE Industrial indices rose by 1.36% and 3.58% respectively. The NSE Banking and the NSE Consumer Goods indices fell by 1.35% and 0.22% respectively while the NSE Oil/Gas index closed flat. Meanwhile, trading activity was weak as total deals, volume and value of stocks traded fell by 3.89%, 14.05% and 9.66% to 3,409 deals, 0.22 billion units and N1.7 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; albeit, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds closed flattish for most maturities tracked; however, the value of FGN Eurobond rose for most maturities tracked.
