

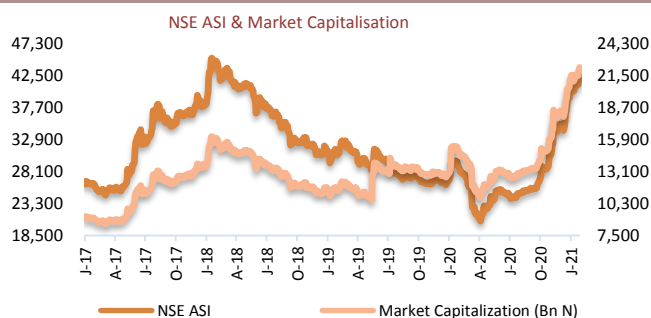


# Cowry Daily Market Insight 4 May 2021

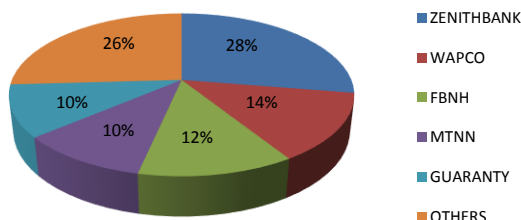
**Domestic Equities Market Index Falls by 0.08% amid Renewed Bearish Activity; NIBOR Moderates for all Tenor Buckets amid Renewed Liquidity Ease...**

The domestic stock market index started the week in negative territory as the ASI declines by 0.08% to close at 39,801.78 points following profit taking activity, especially on large caps. Consequently, the year-to-date loss of the NSE ASI rose to -1.16% albeit the number of gainers (28) outnumbered that of the losers (17) at the close of trading session. Specifically, we saw profit taking on MTNN, WAPCO, ZENITHBANK and UBA shares as their respective prices fell by 0.51%, 5.20%, 1.12% and 1.37%. Of the five indices tracked, four closed in red zone save the NSE Consumer Goods index which rose by 0.71%. The NSE Banking, NSE Insurance, NSE Oil/Gas and the NSE Industrial indices dwindled by 0.32%, 0.86%, 0.29% and 0.57% respectively. Meanwhile, trading activity picked up as total deals, volume and value of stocks traded rose by 30.09%, 34.27% and 56.26% to 5,616 deals, 0.42 billion units and N46 billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid renewed liquidity ease; albeit, NITTY rose for all maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, the value of FGN Eurobond fell for all maturities tracked.
