

At the end of Wednesday's trade, the domestic stock market index moderated by 0.92% to settle at 39,443.81 points amid sustained profit taking activity even as the Exchange recorded more losers (22) than gainers (16). Consequently, the year-to-date loss of the NSE ASI rose to -2.07%. Specifically, investors sold part of their holdings in tickers such as STANBIC, GUARANTY, UNILEVER, ZENITHBANK and JBERGER; hence their respective share prices fell by 10%, 3.65%, 8.21%, 3.18% and 2.33% respectively. Sectorial performance was weak as three out of the five indices tracked closed in red zone; the NSE Banking, NSE Consumer Goods and the NSE Oil/Gas indices dwindled by 1.69%, 0.52% and 229% respectively. On the flip side, the NSE Industrial index rose by 0.29%, while the NSE Insurance index closed flattish. Meanwhile, trading activity was weak as total deals, volume and value of stocks traded fell by 36.43%, 38.9% and 48.59% to 3,570 deals, 0.26 billion units and N2.3 billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid sustained liquidity ease; also, NITTY fell for most maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, the value of FGN Eurobond fell for all maturities tracked.
