


Cowry Daily Market Insight 7 May 2021

Domestic Equities Market Index Rebounds by 0.21% amid Renewed Bullish Activity; NIBOR Rises for all Tenor Buckets amid Renewed Liquidity Strain...

The domestic stock market closed the week positive as the index rose by 0.21% to close at 39,198.75 points amid renewed bargain hunting activity. Also, the Exchange recorded more gainers (25) than losers (17) at the close of trading session even as the year-to-date loss of the NSE ASI fell to -2.66%. Specifically, buying pressure on blue-chip and tier 1 banking stocks such as SEPLAT, GUARANTY, ACCESS and ZENITHBANK increased by 2.58%, 0.86%, 0.62% and 1.14% respectively. Of the five indices tracked, three closed in green zone; the NSE Banking, NSE Consumer Goods and the NSE Oil/Gas indices rose by 1.11%, 0.05% and 2.00% respectively. However, the NSE Insurance and the NSE Industrial indices moderated by 1.07% and 0.12% respectively. Meanwhile, trading activity was weak as total volume and value of stocks traded fell by 33.06% and 33.23% to 0.23 billion units and N2.9 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; albeit, NITTY fell for most maturities tracked. In the OTC bonds market, the values of FGN bonds fell for most maturities tracked; however, the value of FGN Eurobond rose for all maturities tracked.
