Domestic Equities Market Index Rises by 0.29% amid Sustained Bullish Activity; NIBOR Rises for all Tenor Buckets amid Sustained Liquidity Strain...

At the close of Monday's trade, the domestic stock market advanced by 0.29% to close at 39,312.74 points amid positive investors sentiment. Hence, the year-to-date loss of the NSE ASI fell to -2.37% even as the Exchange printed more gainers (28) than losers (15). Specifically, tier 1 banking stocks such as ZENITHBANK, GUARANTY, ACCESS and UBA rose by 3.60%, 2.56%, 2.45% and 1.40% respectively. Also, share price of WAPCO increased by 1.46%. Sectorial performance was positive as three out of the five indices tracked closed in green zone; the NSE Banking, NSE Insurance and the NSE Industrial indices increased by 2.89%, 1.33% and 0.08% respectively. On the flip side, the NSE Consumer Goods and the NSE Oil/Gas indices fell by 0.26% and 0.08% respectively. Meanwhile, trading activity was upbeat as total deal, volume and value of stocks traded rose by 23.31%, 35.68% and 11.10% to 4,867 deals, 0.32 billion units and N3.2 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid sustained liquidity strain; albeit, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds fell for most maturities tracked; however, the value of FGN Eurobond rose for all maturities tracked.
