Bulls Maintain Grip as ASI Advances by 0.25%; NIBOR Rises for all Tenor Buckets amid Sustained Liquidity Strain...

The domestic stock market closed the trading week positive as the All-Share Index rose by 0.25% to close at 39,481.89 points amid sustained positive investors sentiment. Hence, the year-to-date loss of the NSE ASI moderated to -1.95% even as the Exchange recorded more gainers (19) than losers (14). Specifically, buy pressure on tickers such as TOTAL, STANBIC, ETERNA, GUARANTY and ZENITHBANK lifted their respective share prices by 2.11%, 2%, 10%, 1.52% and 1.94%. Of the five indices tracked, four closed in positive territory except for the NSE Industrial index which closed flat. The NSE Banking, NSE Insurance, NSE Consumer Goods and the NSE Industrial indices rose by 1.13%, 1.33%, 0.61% and 0.32% respectively. Meanwhile, trading activity was weak as total volume and value of stocks traded declined by 26% and 13.19% to 0.21 billion units and N2.1 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid sustained liquidity strain; also, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; however, the value of FGN Eurobond fell for all maturities tracked.
