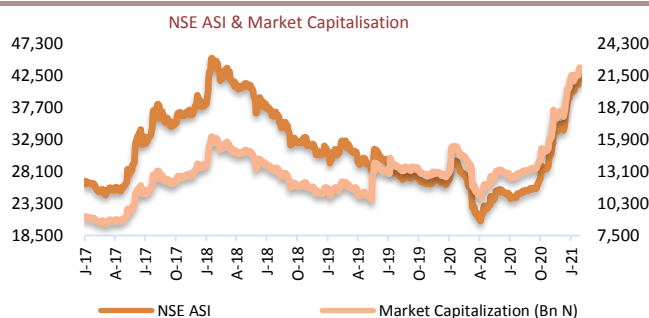


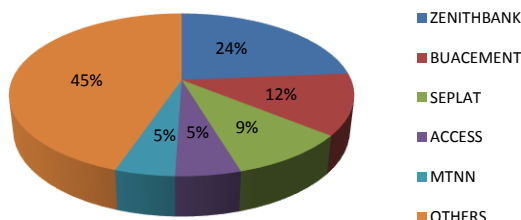
Equities Market Index Sheds 0.72% amid Sustained Bearish Activity; NIBOR Declines for most Tenor Buckets amid Renewed Liquidity Ease...

At the end of Tuesday's trade, the domestic stock market sustained its downward trend as the All-Share Index moderated by 0.72% to close at 39,022.52 points. Hence, the year-to-date loss of the NSE ASI rose to -3.1%. Also, the bears (22) outnumbered the bulls (16) amid sell pressure on mid and large cap stocks. Specifically, share prices of tickers such as BUACEMENT, ZENITHBANK, UACN, LINKASSURE and FBNH moderated by 5.71%, 0.84%, 0.48%, 5.80% and 2.72% respectively. Sectorial performance was weak as three out of five sub-sector gauges tracked closed in red territory; the NSE Insurance, NSE Consumer Goods and the NSE industrial indices fell by 1.37%, 0.05% and 2.57% respectively. On the other hand, the NSE Banking and the NSE Oil/Gas indices rose by 0.03% and 0.26% respectively. Meanwhile, trading activity mellowed as total volume and value of stocks traded declined by 4.36% and 2.38% to 0.20 billion units and N1.8 billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid renewed liquidity ease; however, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds fell for most maturities tracked; albeit, the value of FGN Eurobond rose for all maturities tracked.
