


Cowry Daily Market Insight 19 May 2021

MPR: 11.50% April'21 Inflation Rate: 18.12% Q4 2020 Real GDP: 0.11%

Equities Market Index Declines by 1.48% amid Sustained Bearish Activity; NIBOR Declines for most Tenor Buckets amid Sustained Liquidity Ease...

The domestic stock market Index moderated by 1.48% to close at 38,445.09 points amid sustained bearish activity even as the Exchange recorded more losers (25) losers than gainers (23) at the close of trading session. Hence, the year-to-date loss of the NSE ASI ballooned to -4.5%. Notably, the NSE Oil/Gas index increased by 7.1% buoyed by buy pressure on SEPLAT which rose as high as 10%. However, this gain was offset by sell pressure on large cap stocks such as AIRTELAFRI, DANGCEM and ZENITHBANK. Their respective share prices fell by 10%, 0.47% and 2.13%. Sectorial performance remained weak as three out of the remaining sub-sector indices closed in red territory save for the NSE Industrial Index which rose by 0.85%. The NSE Banking, NSE Insurance and the NSE Consumer Goods indices fell by 0.62%, 0.61% and 0.32% respectively. Elsewhere, NIBOR fell for most tenor buckets amid sustained liquidity ease; however, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; albeit, the value of FGN Eurobond fell for all maturities tracked.
