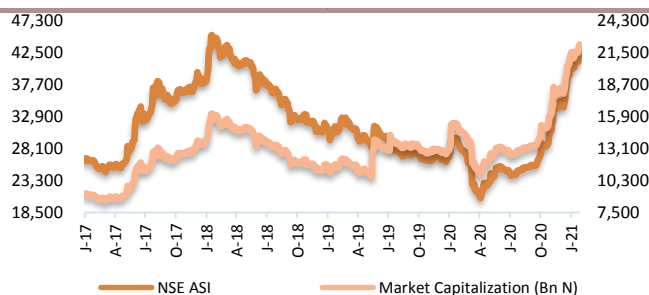
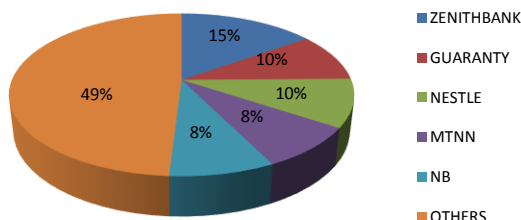


Local Equities Market Closes Southwards as ASI Declines by 0.10%; NIBOR Rises for all Tenor Buckets amid Financial Liquidity Strain...

The domestic bourse started the week in negative territory as its All-Share Index (ASI) moderated by 0.10% to close at 38,287.58 points; albeit the Exchange printed more gainers (18) than losers (17). Hence, the year-to-date loss of the NSE ASI rose to -4.92%. Notably, the positive real GDP report of 0.51% for Q1 2020 did not quench the negative sentiment in the market. We saw tickers such as GUARANTY, ETERNA, ACCESS and ALLCO closed lower by 0.85%, 2.50%, 0.15% and 0.06% amid sell pressure. Sectorial performance was weak as three out of the five indices tracked closed in red zone; the NSE Banking, NSE Insurance and the NSE Consumer Goods indices fell by 0.68%, 0.75% and 0.68% respectively. On the positive side, the NSE Oil/Gas and the NSE Industrial indices rose by 0.21% and 0.09% respectively. Meanwhile, trading activity picked up as total deals and volume of stock traded rose by 103.42% and 64.54% to 3,566 deals and 0.14 billion units respectively. Elsewhere, NIBOR rose for all tenor buckets amid renewed liquidity strain; also, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; albeit, the value of FGN Eurobond rose for most maturities tracked.
