


Equities Market Index Sheds 0.06% amid Sustained Bearish Activity; NIBOR Falls for all Tenor Buckets amid Financial Liquidity Ease...


At the end of Wednesday's trade, the domestic bourse All-Share Index (ASI) further declined by 0.06% to close at 38,233.68 points; albeit the number of gainers (20) outweighed that of the losers (14). Hence, the year-to-date loss of the NSE ASI worsened to -5.05%. Specifically, sell-offs in tier 1 banking stocks such as ZENITHBANK, GUARANTY, UBA and FBNH moderated by 1.08%, 0.70%, 0.70% and 0.70% respectively. Also, FLOURMILL fell by 5.25%. Sectoral performance was mixed as two of the indices tracked closed southwards while the others moved in mixed directions. The NSE Banking and the NSE Consumer Goods indices fell by 0.44% and 0.08% respectively. On the other hand, the NSE Insurance index rose by 1.17% while the NSE Oil/Gas and the NSE Industrial indices closed flat. Meanwhile, trading activity was positive as total deal and value of stock traded rose by 1.70% and 16.99% to 3,594 deals and N1.8 billion respectively. Elsewhere, NIBOR fell for all tenor buckets amid sustained liquidity ease; however, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; however, the value of FGN Eurobond rose for all maturities tracked.
