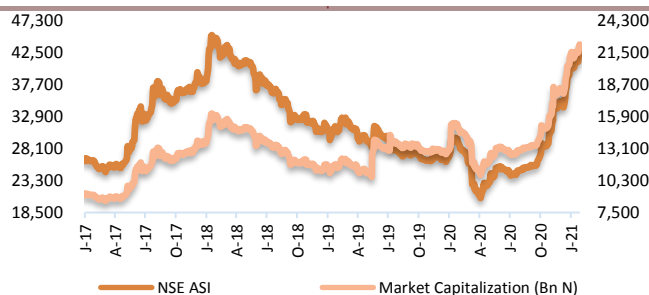
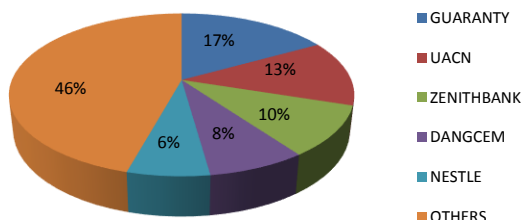


Local Equities Market Index Closes in Negative Territory as the ASI Falls by 0.49%; NIBOR Rises for most Tenor Buckets amid Financial Liquidity Strain...

The domestic bourse All-Share Index (ASI) moderated by 0.49% to close at 38,233.68 points following sell-off on mid and large cap stocks. Hence, the year-to-date loss of the NSE ASI rose to -5.52% even as the number of losers (21) outweighed that of the gainers (16). Specifically, sentiment remained negative in the market as investors sold part of their holdings in Tickers such as DANGCEM, UACN, GUARANTY and ETERNA. Their respective share prices moderated by 2.86%, 2.22%, 1.23% and 3.21%. Breakdown across sub-sectors indices indicated that four out of the five indices tracked closed in red zone: the NSE Banking, NSE Insurance, NSE Oil/Gas and the NSE Industrial indices fell by 0.36%, 0.25%, 1.11% and 1.07% respectively. On the positive side, the NSE Consumer Goods index rose by 0.13%. Meanwhile, trading activity was weak as total deal and value of stock traded fell by 0.81% and 26.37% to 3,565 deals and N1.3 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity ease; however, NITTY fell for most maturities tracked in tandem with the declining stop rate for 364-day bill. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; also, the value of FGN Eurobond fell for all maturities tracked.
