

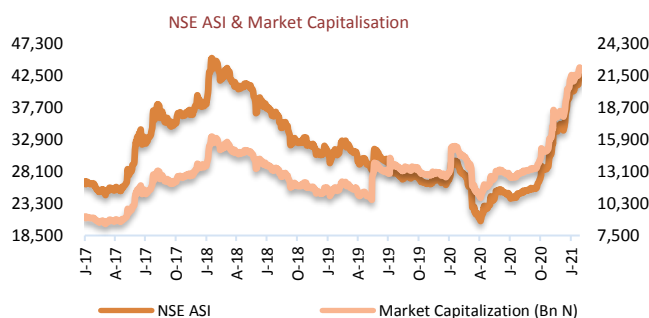


# Cowry Daily Market Insight 28 May 2021

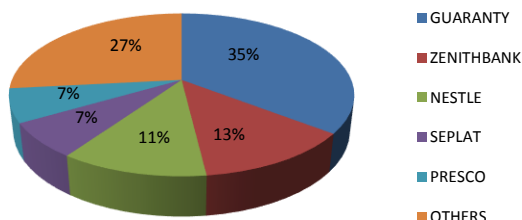
Local Equities Market Index Rebounds by 0.56% amid Renewed Bargain Hunting; NIBOR Falls for most Tenor Buckets amid Financial Liquidity Ease...

At the end of Friday's trade, the domestic bourse closed positive as the All-share Index rose by 0.56% to 38,256.99 points. Consequently, the year-to-date loss of the NSE ASI fell to -5.0%. Given the positive sentiment, the Exchange printed higher number of gainers (31) than losers (12). Notably, large cap stocks such as SEPLAT, NESTLE, DANGCEM, MTNN and ZENITHBANK were the toast of investors today as their respective share prices increased by 2.43%, 1.12%, 4.17%, 0.25% and 0.44%. Sectorial performance was positive as all the sub-sector indices tracked closed in green territory: the NSE Banking, NSE Insurance, NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices rose by 0.14%, 2.50%, 0.56%, 1.78% and 0.57% respectively. Meanwhile, trading activity was upbeat as total volume and value of stock traded rose by 6.77% and 174.61% to 0.22 billion units and N1.3 billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid renewed liquidity ease; however, NITTY moved in mixed directions for most maturities tracked. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; albeit, the value of FGN Eurobond declined for all maturities tracked.
