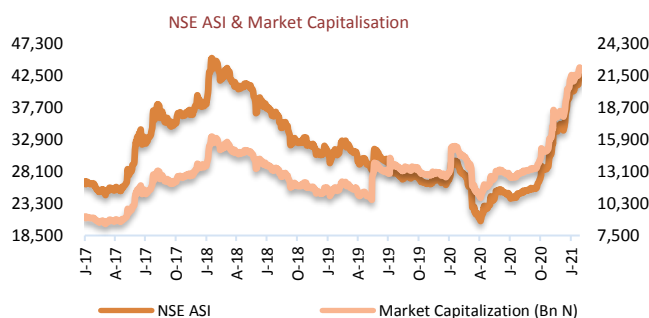


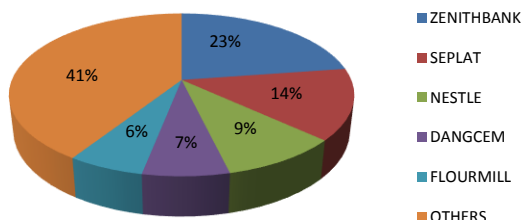
Local Equities Market Index Rises by 0.47% amid Sustained Bargain Hunting Activity; NIBOR Rises for most Tenor Buckets amid Financial Liquidity Strain...

The domestic bourse resumed the week positive as its All-Share Index (ASI) advanced by 0.47% to close at 38,437.88 points amid bargain hunting activity. Hence, the year-to-date loss of the NSE ASI fell to -4.5% despite the number of losers (21) outnumbering that of the gainers (17). Specifically, buying pressure on heavy weight stocks such as BUACEMENT, MTNN and GUARANTY lifted their respective share prices by 2.78%, 0.99% and 1.43% respectively. Of the five indices tracked, three closed in green zone; the NSE Banking, NSE Oil/Gas and the NSE Industrial indices increased by 0.32%, 0.01% and 1.13% respectively. Meanwhile, trading activity mellowed as total volume and value of stock traded fell by 11.73% and 42.26% to 0.20 billion units and N2.1 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; also, NITTY rose for all maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions for most maturities tracked; albeit, the value of FGN Eurobond expanded for most maturities tracked.
