

The domestic bourse reversed yesterday's gains as the All-Share Index (ASI) moderated by 0.06% to close at 38,414.37 points; albeit the number of gainers (18) outweighed that of the losers (17). Hence, the year-to-date loss of the NSE ASI rose to -4.6% at the end of Tuesday's trade. Sentiment was negative in the market as investors sold part of their holdings in tickers such as SEPLAT, WAPCO, ZENITHBANK and HONEYFLOUR. Consequently, their respective share prices plummeted by 1.16%, 0.94%, 0.65% and 6.61%. Sectorial performance was weak as four out of the five indices tracked closed in red zone save for the NSE Insurance index which rose by 1.51%. The NSE Banking, NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices fell by 0.13%, 0.27%, 0.86% and 0.06% respectively. Meanwhile, trading activity was upbeat as total deal, volume and value of stock traded rose by 8.68%, 36.16% and 24.17% to 4,159 deals, 0.27 billion units and N2.6 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity strain; albeit, NITTY fell for most maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions for most maturities tracked; however, the value of FGN Eurobond increased for most maturities tracked.
