

## Cowry Daily Market Insight 02 June 2021

MPR: 11.50% April'21 Inflation Rate: 18.12% Q1 2021 Real GDP: 0.51%

Local Equities Market Index Rebounds by 0.18% amid Renewed Bargain Hunting Activity; NIBOR Rises for all Tenor Buckets amid Financial Liquidity Squeeze... At the end of Wednesday's trade, the domestic bourse index rallied by 0.18% to close at 38,482.52 points amid renewed bargain hunting; albeit the Exchange recorded 15 gainers as against 20 losers. Hence, the year-to-date loss of the NSE ASI moderated to -4.4%. Counters such as DANGCEM, NEM, UNILEVER and ZENITHBANK were the toast of investors today as their respective share prices increased by 1.41%, 2.42%, 0.85% and 0.44%. Breakdown across sectored gauges indicated that three out of five indices tracked closed in green zone: the NSE Banking, NSE Insurance and the NSE Industrial indices rose by 0.02%, 0.76% and 0.50% respectively. On the flip side, the NSE Consumer Goods and the NSE Oil/Gas indices dwindled by 0.16% and 0.05% respectively. Meanwhile, trading activity mellowed as total deal, volume and value of stock traded fell by 21.30%, 42.91% and 49.51% to 3,273 deals, 0.15 billion units and N1.3 billion respectively. Elsewhere, NIBOR rose for all tenor buckets amid sustained liquidity strain; albeit, NITTY fell for most maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; however, the value of FGN Eurobond increased for most maturities tracked.
