


## Cowry Daily Market Insight 03 June 2021

MPR: 11.50% April'21 Inflation Rate: 18.12% Q1 2021 Real GDP: 0.51%

Local Equities Market Maintains Bullish Trend as ASI Advances by 0.17%; NIBOR Falls for all Tenor Buckets amid Financial Liquidity Ease...

The domestic bourse index increased by 0.17% to close at 38,548.24 points amid sustained bullish momentum even as the Exchange recorded 17 gainers as against 15 losers at the close of trading session. Hence, the year-to-date loss of the NSE ASI moderated to -4.27%. Notably, sentiment remained positive in the market as mid and large cap stocks such as MTNN, ZENITHBANK, FLOURMILL and WAPCO enjoyed investors patronage. Consequently, their respective share prices increased by 1.48%, 0.22%, 1.06% and 0.49%. Of the five indices tracked, four closed in positive territory except for the NSE Banking Index which moderated by 0.50%. The NSE Insurance, NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices rose by 0.06%, 0.23%, 0.05% and 0.01% respectively. Meanwhile, trading activity was upbeat as total deal, volume and value of stock traded rose by 7.67%, 59.13% and 41.16% to 3,524 deals, 0.24 billion units and N1.8 billion respectively. Elsewhere, NIBOR fell for all tenor buckets amid renewed liquidity ease; albeit, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds rose for most maturities tracked; also, the value of FGN Eurobond increased for maturities tracked.
