

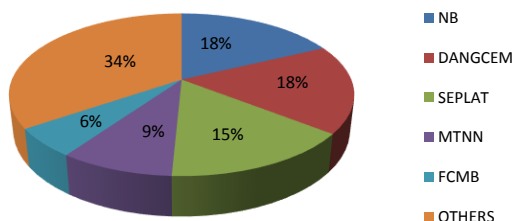
Local Equities Market Closes Positive as ASI Rises by 0.46%; NIBOR Rises for all Tenor Buckets amid Financial Liquidity Strain...

At the end of Friday's trading session, the domestic bourse index advanced by 0.46% to close at 38,726.10 points amid sustained bullish momentum; hence, the year-to-date loss of the NSE ASI moderated to -3.83%. Similarly, the Exchange recorded 22 gainers as against 10 losers. Specifically, share prices of Counters such as DANGCEM, MTNN, GUARANTY, FCMB and ETERNA rose by 2.09%, 0.06%, 0.88%, 4.76% and 2.63% respectively. Of the five indices tracked, four closed in positive territory except for the NSE Insurance Index which moderated by 0.56%. The NSE Banking, NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial indices rose by 0.33%, 0.04%, 0.06% and 1.00% respectively. Meanwhile, trading activity was weak as total deal, volume and value of stock traded rose by 10.61%, 20.27% and 15.20% to 3,150 deals, 0.19 billion units and N1.5 billion respectively. Elsewhere, NIBOR rose for all tenor buckets amid renewed liquidity squeeze; also, NITTY rose for most maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions for most maturities tracked; albeit, the value of FGN Eurobond fell for maturities tracked.
