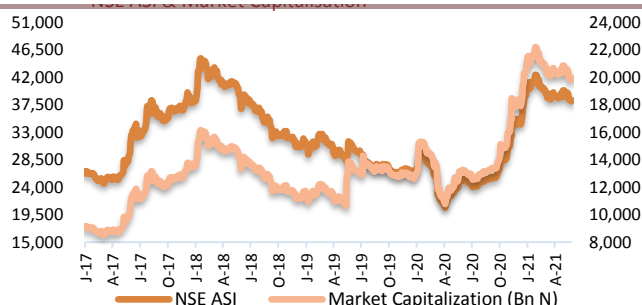
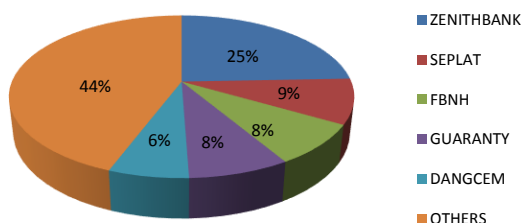


## Local Equities Market Index Moderates by 0.10% amid Renewed Profit Taking; NIBOR Rises for most Tenor Buckets amid Financial Liquidity Strain...

The domestic bourse resumed the week in negative territory as the All-Share Index moderated by 0.10% to close at 38,686.40 points amid renewed profit taking activities; hence, the year-to-date loss of the NSE ASI rose to -3.93%. Sentiment was negative in the market as the Exchange recorded more losers (27) than gainers (13) at the close of trading session. Notably, share prices of tickers such as GUARANTY, WAPCO, UNILEVER, AIICO and UBA moderated by 1.22%, 1.22%, 2.10%, 2.61% and 0.70% respectively. Performance across sub-sector gauges tracked was weak as four out of the five indices tracked closed in red zone; the NSE Banking, NSE Insurance, NSE Consumer Goods and the NSE Industrial indices fell by 0.86%, 1.91%, 0.09% and 0.04% respectively. On the positive side, the NSE Oil/Gas index rose by 0.31%. Meanwhile, trading activity was positive as total deals and volume of stock traded rose by 25.65% and 5.87% to 3,958 deals and 0.21 billion units respectively. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity squeeze; albeit, NITTY fell for most maturities tracked. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; albeit, the value of FGN Eurobond rose for maturities tracked.
