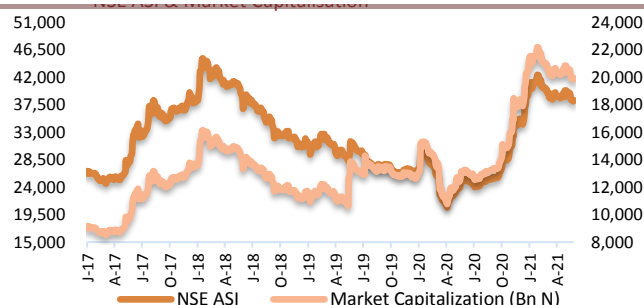
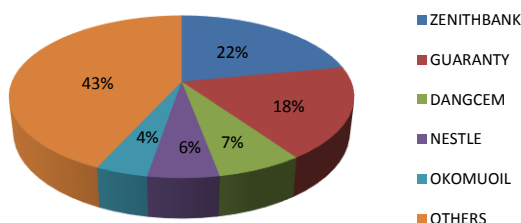


Local Equities Market Index Rebounds by 0.50% amid Renewed Bargain Hunting Activity; NIFTY Falls for Most Maturities Tracked amid Demand Pressure...

At the close of Tuesday's trading session, the domestic bourse advanced by 0.50% to close at 38,881.70 points amid renewed bullish activity; albeit the Exchange recorded more losers (17) than gainers (15). Hence, the year-to-date loss of the NSE ASI fell to -3.44%. Notably, tickers such as DANGCEM, OKOMUOIL, FLOURMILL, GUARANTY and ETERNA were the toast of investors today as their respective share prices increased by 2.27%, 10%, 246%, 0.35% and 2.56%. Sectorial performance was positive as three out of the five indices tracked closed in green; the NSE Consumer Goods, NSE Oil/Gas and the NSE Industrial Indices rose by 0.57%, 0.08% and 1.04% respectively. On the flip side, the NSE Banking and the NSE Insurance indices moderated by 0.05% and 1.03% respectively. Meanwhile, trading activity was positive as total volume and value of stock traded rose by 3.68% and 6.04% to 0.21 billion units and N1.5 billion respectively. Elsewhere, NIBOR moved in mixed directions for most tenor buckets; albeit, NIFTY fell for most maturities tracked amid demand pressure. In the OTC bonds market, the values of FGN bonds moved in mixed directions for most maturities tracked; albeit, the value of FGN Eurobond rose for all maturities tracked.
