

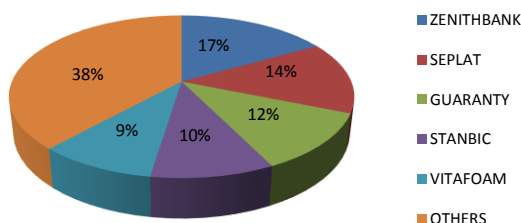
Domestic Equities Market Reverses Uptrend as the Index Moderates by 0.14%; NIBOR Falls for most Tenor Buckets amid Financial Liquidity Ease...

The local bourse closed the trading week in negative territory as the All-share Index fell by 0.14% to close at 39,156.28 points; albeit the Exchange printed more gainers (25) than losers (16). Hence, the year-to-date loss of the NSE ASI rose to -2.76%. Specifically, blue-chip stocks such as SEPLAT, WAPCO, FBNH, ZENITHBANK and ACCESS advanced by 1.47%, 0.48%, 0.70%, 0.22% and 0.61% respectively amid demand pressure. Sectorial performance was positive as three out of five indices tracked closed in green zone; the NSE Banking, NSE Oil/Gas and the NSE Industrial indices rose by 0.05%, 0.94% and 0.03% respectively. On the flip side, the NSE Insurance and the NSE Consumer Goods indices fell by 0.56% and 0.15% respectively. Meanwhile, trading activity was positive as total deals, volume and value of stock traded rose by 11.68%, 82.54% and 58.52% to 3,719 deals, 0.28 billion units and N2.8 billion respectively. Elsewhere, NIBOR declined for most tenor buckets amid financial liquidity ease; albeit, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; albeit, the value of FGN Eurobond rose for all maturities tracked.
