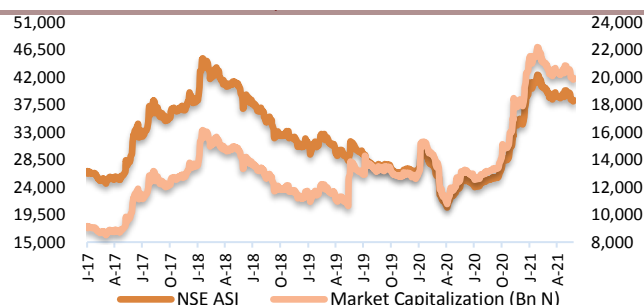
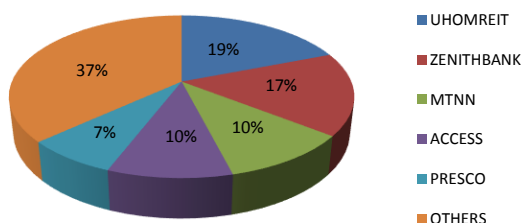


## Domestic Equities Market Closes Southwards by 1.66%; NIBOR Rises for most Tenor Buckets amid Financial Liquidity Strain...

The local bourse resumed the week in negative territory as the All-Share Index moderated by 1.66% to close at 38,507.33 points; hence, the year-to-date loss of the NSE ASI worsened to -4.37%. Also, the Exchange printed more losers (26) than gainers (19) amid sell pressure. Specifically, investors were bearish on Consumer Goods sector as share prices of OKOMOOIL, PRESCO, UACN and FLOURMILL fell by 9.44%, 2.50%, 2.06% and 1.00% respectively. Also, share price of AIRTELAFRI fell by 10% at the close of trade. Most of the indices performance was positive as three out of five sub-sector tracked closed in green zone; the NSE Banking, NSE Insurance and the NSE Oil/Gas indices rose by 0.16%, 0.41% and 0.13% respectively. On the flip side, the NSE Consumer Goods index declined by 0.18% while the NSE Industrial index closed flat. Meanwhile, trading activity was upbeat as total deals, volume and value of stock traded rose by 18.37%, 2.86% and 2.96% to 4,402 deals, 0.29 billion units and N3.6 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid financial liquidity squeeze; also, NITTY rose for all maturities tracked. In the OTC bonds market, the values of FGN bonds moved in mixed directions for most maturities tracked; albeit, the value of FGN Eurobond fell for most maturities tracked.
