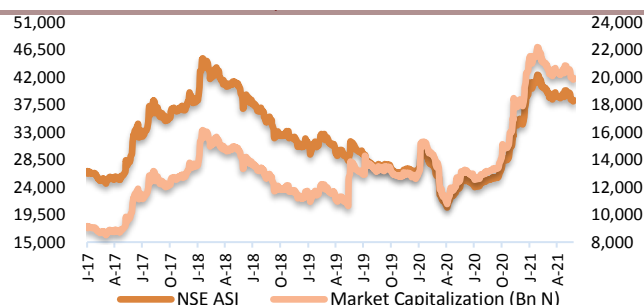
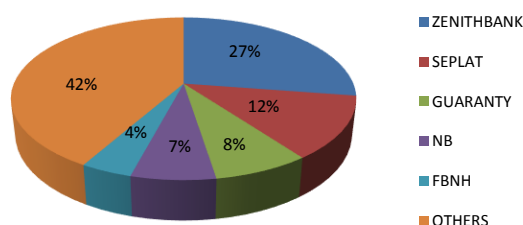


## Equities Market Index Advances by 0.13% amid Sustained Bullish Activity; NIBOR Falls for most Tenor Bucket amid Financial Liquidity Ease...

The local bourse All-Share Index advanced by 0.13% to close at 38,615.11 amid sustained bargain hunting activity even as the number of gainers (18) recorded outweighed that of the losers (8) at the close of trading session. Consequently, the year-to-date loss of the NSE ASI fell to -4.11%. Specifically, mid and large cap stocks such as NB, UACN, GUARANTY, WAPIC and ZENITHBANK were the toast of investors today as their respective share prices rose by 1.20%, 1.57%, 1.78%, 0.43% and 9.43%. Also, sectorial performance was positive as three out of the five indices tracked closed in green zone; the NSE Banking, NSE Insurance and the NSE Consumer Goods indices rose by 0.81%, 1.01% and 0.18% respectively. On the flip side, the NSE Industrial index fell by 0.02% while the NSE Oil/Gas index closed flat. Meanwhile, trading activity was weak as total deals, volume and value of stock traded fell by 25.69%, 47.00% and 50.34% to 3,260 deals, 0.16 billion units and N1.3 billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid financial liquidity ease; albeit, NITTY rose for all maturities tracked even as the stop rates for the 364-day tenor fell to 9.4%. Stop rates for 91-Day and 182-Day maturities closed flat. In the OTC bonds market, the values of FGN bonds moved in mixed directions for most maturities tracked; albeit, the value of FGN Eurobond fell for all maturities tracked.
