Equities Market Index Rises by 0.09% amid Sustained Bullish Activity; NIBOR Falls for most Tenor Bucket amid Financial Liquidity Ease...

The local bourse All-Share Index advanced by 0.09% to close at 38,648.91 points amid sustained bargain hunting activity even as the Exchange printed more gainers (17) than losers (10) at the close of trading session. Consequently, the year-to-date loss of the NSE ASI fell to -4.02%. Specifically, tickers such as PRESCO, FLOURMILL, ZENITHBANK, CORNEST and ACCESS enjoy investors patronage as their respective share prices increased by 2.70%, 1.02%, 1.28%, 5.45% and 0.59%. Of the five indices tracked, two closed in green territory while others moved in mixed directions; the NSE Banking and the NSE Consumer Goods indices rose by 0.44% and 0.07% respectively. On the flip side, the NSE Insurance index fell by 0.15% while the NSE Oil/Gas and the NSE Industrial indices closed flat. Meanwhile, trading activity was upbeat as total volume and value of stock traded rose by 37.52% and 81.24% to 0.22 billion units and N2.5billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid financial liquidity ease; albeit, NITTY rose for all maturities tracked. In the OTC bonds market, the values of FGN bonds moderated for most maturities tracked; however, the value of FGN Eurobond rose for most maturities tracked.
