


Equities Market Index Moderates by 0.27% amid Renewed Bearish Activity; NIBOR Rises for most Tenor Bucket amid Financial Liquidity Strain...

The local bourse All-Share Index moderated by 0.27% to close at 38,545.30 points amid renewed profit hunting activity; albeit the Exchange printed more gainers (18) than losers (17) at the close of trading session. Consequently, the year-to-date loss of the NSE ASI rose to -4.28%. Specifically, sell pressure on small and medium cap tickers such as FIDSON, LASACO, ETI, OANDO and FCMB lowered their respective share prices by 9.80%, 9.33%, 0.96%, 1.68% and 1.25%. Sectorial performance was weak as three out of the five indices tracked closed southwards; the NSE Insurance, the NSE Oil/Gas and the NSE Industrial indices declined by 1.13%, 0.07% and 1.15% respectively. On the positive side, the NSE Banking and the NSE Consumer Goods indexes rose by 0.11% and 0.06% respectively. Meanwhile, trading activity was upbeat as total volume and value of stock traded fell by 5.18% and 30.27% to 0.20 billion units and N1.7 billion respectively. Elsewhere, NIBOR rose for most tenor buckets amid financial liquidity strain; albeit, NITTY fell for all maturities tracked. In the OTC bonds market, the values of FGN bonds were flattish for most maturities tracked; albeit, the value of FGN Eurobond fell for all maturities tracked.
